- 2. Review of Prior Meeting Minutes
 - a. October Parish Council Meeting minutes accepted as submitted.
- 3. Financial Report
 - a. Key Points:
 - i. October income versus expenses was almost break-even.
 - ii. Budget deficit for January through October is ~\$9,500.
 - iii. Interest was not transferred to the operational account this month to supplement income.
 - iv. Income for the November Bake Sale was \$1,807. (This income will be included in the November financial report.)
 - v. The October financial report was accepted as submitted.
- 4. Father John's Report
 - a. OCA Pension Plan
 - i. One of the rules governing the OCA pension plan is that a priest cannot collect a salary once retired. The rules also do not specify an age for collecting benefits.
 - ii. An alternative to investing in the OCA pension plan would be to invest money in a private retirement fund.
 - iii. Fr. John to investigate further and provide additional information to the Council.
- 5. Growth & Development
 - a. 3156 Holland Road Property
 - i. The conditional use permit granted for the property has expired. New application would need to be submitted but full detailed drawings would not be required.
 - ii. Discussed the information to be presented to the parish at the informational meeting scheduled for 11/23/14.
